Patient Safety Awareness Week is March 13 - 18. The Institute for Healthcare Improvement is hosting two webinars in recognition of Patient Safety Awareness Week.



- The March 14th webinar **Back to Our Purpose: The Reboot of Safety,** will discuss the results of a study published in the New England Journal of Medicine in January 2023. This study used trigger tool methodology to determine that an adverse event occurred in nearly one in four admissions in 2018 among 11 Massachusetts hospitals. An accompanying editorial by Donald Berwick, MD concludes that the patient safety movement has stalled as the attention of leaders has been diverted away from patient safety to multiple other priorities including preparedness, shortages of resources, and workforce burnout.
- The March 15th webinar will focus on *Partnering with Patients to Improve Diagnostic* Safetv.

NCPS Shared Learning Resources

This month's Learning Resource is a De-identified Event that addresses the topic of Unlabeled Patient Specimens. The evidence-based solution to the problem of unlabeled specimens is the use of two patient identifiers before providing any care. The use of two patient identifiers must be hardwired by training that begins during health professions education and is reinforced by audits within each health care organization. (AQIPS) will summarize essential steps needed to establish a Patient Safety Evaluation System (PSES). A functioning PSES is essential to receive the confidentiality and privilege protections conferred by membership in a Patient Safety Organization. Involving patients and carers in patient safety in primary care: a qualitative study of a

co-designed patient safety guide. Patient and caregiver engagement is an important strategy for improving the quality and safety of care. This qualitative study with 18 patients and/or caregivers explored perspectives on

engagement in primary care. While participants were supportive of engagement in their care and safety, some expressed concerns regarding additional workload for patients. Participants also provided feedback on a patient safety guide for primary care (PSG-PC) and identified areas to embed the PSG-PC into routine interactions with primary care, particularly for individuals caring for a family member with complex or chronic health conditions. The End of an Influential Resource On March 10, 2023, Johns Hopkins closed their Coronavirus Resource Center. The dashboards

they created and hosted on this website tracked rates of infections, hospitalizations, and deaths by location (country, state, county, or region). This information was a crucial resource for health policy decision makers, especially at the beginning of the pandemic. At that time neither the Centers for Disease Control and Prevention (CDC) or the World Health Organization were providing this data. The Johns Hopkins site launched on March 3, 2020. It was created by Lauren Gardener, an engineering professor at Johns Hopkins, and one of her students. The site was created and largely run by women. It cost \$13 million and eventually drew more than 2.5 billion views. With the threat of the pandemic receding, states are reporting data less frequently and the CDC has ramped up the agency's data reporting, so the university decided it was time to shut it down.
