### NCPS Update: July 2022

### A Message from the Patient Safety

The impact of the current COVID-19 pandemic continues being felt in all areas of Americans' lives. The U.S. Census Bureau, in collaboration with multiple federal agencies, launched the Household Pulse Survey in April 2020 to produce data on the social and economic impacts of COVID-19



on American households. A variety of areas were targeted for survey including employment status, consumer spending, food security, housing, education disruptions, and dimensions of physical and mental wellness. By obtaining accurate and timely weekly estimates of these metrics, the goal of improving response time for identified problem areas was thought to be more attainable. Beginning June 1, 2022 questions about long COVID were added to the survey. The June 1 – June 13, 2022 survey found that nearly 1 in 5 American adults who reported having COVID-19 are still having symptoms of long COVID. Nebraska's statistics do show a lower percentage (12.8%) than the average; however, this does present a concern for its potential impact to an already stressed healthcare system. The detailed information from this survey may be found <u>here</u>. A significant consequence of the COVID-19 pandemic for healthcare providers has been an

increase in the number of patient complaints to state agencies, CMS, and The Joint Commission regarding patient safety issues. Staffing shortages and pandemic-related process changes are two of the primary reasons for these complaints. A recent Becker's Hospital Review webinar sponsored by Chartis Clinical Quality Solutions featured three Chartis' compliance experts discussing practical approaches to addressing common pain points in regulatory and accreditation surveys; and how to apply these approaches to improve patient safety. The webinar recording is no longer posted on Chartis' website, however you can download a copy of the presentation slides found here. A key point made by one of the speakers is that most CMS termination actions are triggered

by adverse clinical event(s) involving patient harm. And the remedy for such events is to identify Harm Events and then: 1). understand the true causes of Harm Events

- 2). focus on and fix the flaws in the systems that cause Harm Events
- 3). sustain improvements
- These are actions which align well with NCPS' process of helping protect patients by

collaborating with our members through the patient safety organization process of Report, Analyze, Share, Learn, Improve. Chartis has also provided a Q&A resource on their website which includes the top questions

You may have seen on AHRQ's website that they recently released a new common format for the

reporting of diagnostic safety events. It has long been realized that improving diagnosis and reducing diagnostic error are patient safety priorities; yet the existing tools to analyze diagnostic

Patient safety competencies in nursing are essential for the provision of quality healthcare. This 2011 systematic review published online in the BMJ Open Quality, identified nine tools to assess

#### safety events (i.e. diagnoses that are delayed, wrong, missed, or not communicated to the patient) are not structured to collect data in a standardized manner which then allows analysis and sharing of lessons learned. This 1.0 version of common formats for Diagnostic Safety Events is an

attempt to bridge that deficit in the existing common formats. The Diagnostic Safety common formats are considerably different in their layout than the current common formats so we will be working with our software vendor and our members to determine how we might best incorporate this new tool into our event reporting.
