

Care This toolkit was developed by the National Confidential Inquiry into Suicide and Safety in Mental Health based on in-depth information collected on all suicides in the UK since 1996. NCISH's goal is to improve safety for all mental health patients regardless of the patient's location (i.e. mental health services, primary care, emergency departments). The toolkit was designed to be used as the basis for a self-assessment and presents the 10 key elements for safer care for patients which have been shown to reduce suicide rates. ECRI will launch a Perioperative Safety Collaborative beginning in January 2022. The authors of this abstract explain how they refined and automated a previously developed emergency department trigger tool. Their results showed a promising approach to improve yield, scope, and efficiency of review for all-cause harm in emergency medicine.
