The IHI blog proposes actionable steps and resources to identify and fix the cracks in the foundation of patient safety which have been exposed during the pandemic; and to consider them part of the core recovery work needed. As McGaffigan states, "Without refortification, progress in safety will be limited as our attention moves to our next burning platform, and sustainability of progress will remain elusive". The NCPS learning resource this month is a Reporting Committee Summary [SCL1] which focuses on an event where the result of a lab test (a positive COVID-19 test) was not on the

patient's chart when the patient was admitted for an outpatient procedure and then later

misinterpreted by a clinician as being negative. The nurse caring for the patient was also caring for other patients including a new mother and baby. This summary includes information and resources about the importance of having procedures in place for notifying clinicians of critical and/or significant lab test results, utilizing a pre-op checklist, and the importance of a culture of safety in any healthcare setting. It contains an organizational self-assessment, "Could this happen in your organization?" to help identify gaps and next steps in developing risk mitigation strategies to reduce the potential for similar adverse events.
