## **NCPS Shared Learning Resource**

Research has long shown that a patient's safety is at great risk during transitions of care (i.e., their movement from one care setting to another based on their changing healthcare needs). Inadequate communication and coordination during discharge was listed as ECRI's #9 concern on their 2025 list of Top 10 Patient Safety Concerns.[1] This month's shared learning is a Patient Safety Alert addressing this topic, Inadequate Communication and Coordination During Discharge. Included in the alert are resources to aid members in developing processes to reduce the likelihood of patient harm during a care transition. The National Transitions of Care's Care Transition Bundle Seven Essential Interventions is one such reference [2], as is the Agency for Healthcare Research and Quality's Health Literacy Universal Precautions Toolkit [3]. This Toolkit offers evidence-based guidance to help healthcare providers make health information easier to understand and act on, make healthcare easier to navigate, and increase support for patients of all health literacy levels. # Report from AHRQ's Summit to Address Emergency Department Boarding - Strategies To Reduce Emergency Department Boarding

ED boarding has serious impacts on patients, including excess in-hospital mortality, increased medical errors and costly delays in care delivery. It also negatively impacts hospital staff and public safety. This AHRQ report shows that the causes of emergency department (ED) boarding originate at the hospital or health system level and require solutions beyond the walls of the ED. The report presents solutions from the perspective of hospital or health system levels and notes opportunities for health systems, states and federal partners to lead efforts moving forward. ## **Strategies for Communicating With Parents About Vaccines**

Vaccines in the current child and adolescent immunization schedule are safe, highly effective, and have prevented an estimated 146 million deaths worldwide among children younger than 5 years. Even so, clinicians increasingly encounter parents with questions and concerns about vaccines and may be unsure how best to respond. Effective communication strategies can help clinicians build trust, navigate difficult vaccine conversations, strengthen parental intention to vaccinate, and improve vaccine uptake. ## **CMS Weighs Dropping Some Quality Measures: What to Know**

On April 11, 2025 <u>CMS published proposed changes</u> as part of its 2026 proposed rule for the Medicare payment system.

The modification for four current quality measures includes:

- Total hip arthroplasty/Total knee arthoplasty complication rate and 30-day stroke mortality
- Hybrid, hospitalwide readmission and mortality measures

Additionally, CMS is proposing the removal of four measures from the IQR program, beginning with the 2024 reporting period and the fiscal 2026 payment determination period. The measures are:

- Hospital Commitment to health equity
- COVID-19 vaccination coverage among healthcare personnel
- Screenings for social drivers of health
- Screen positive rate for social drivers of health

CMS is accepting comments on the proposed changes through June 13.
